The Federal Information Technology Acquisition Reform Act

(FITARA) requires the heads of Federal agencies to ensure that their respective chief information officers (CIOs) have a significant role in information technology (IT) decisions, including annual and multi-year



planning, programming, budgeting, execution, reporting, management, governance, and oversight functions. In spite of many uncertainties as to what to expect from the new law, federal leaders can begin with these three steps - 1) Establish agency-level "FITARA board" to include the agency senior leadership 2) Define scope of IT 3) Evaluate current governance processes for IT budget, acquisition, and program management.
